I agree that I will supervise my child myself during the Activities, arrange for appropriate adult supervision of my child, or if my child is over twelve years old will accept responsibility for any consequences of my child's actions while unsupervised.

I acknowledge and understand that it is my responsibility to review and consider any warnings, alerts, and other information provided by the Centers for Disease Control and Prevention, other federal agencies, and state and local health authorities that concern in-person indoor or outdoor activities, including the Activities. I specifically acknowledge and understand that it is possible that there may be COVID-19 infections present among Convention attendees, organizers, participants, or other individuals who are present, regardless of their vaccination status, and that by allowing my child to participate in the Activities, my child may be exposed to COVID-19.

ALL OF THE SERVICES COMPRISING THE ACTIVITIES, WHETHER PROVIDED BY URGE OR BY THIRD PARTIES, ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND. I understand and agree that Women's March is not responsible for the errors, omissions, acts, or failures to act of any of third parties conducting or providing the Activities.
- 7. I understand that my child's name, photograph, voice, likeness, testimonials, and/or biographical information may be used for any and all purposes, including, but not limited to, advertising, trade, and/or promotion on behalf of Women's March, its licensees, affiliates, suppliers, and employees, and I CONSENT TO AND AUTHORIZE IN ADVANCE ALL SUCH USE. I further understand that I will not benefit financially or otherwise from any use thereof.
- 8. I HEREBY RELEASE, DISCHARGE, COVENANT NOT TO SUE, AND AGREE TO INDEMNIFY, SAVE AND HOLD HARMLESS WOMEN'S MARCH (AND, IF I HAVE GIVEN MY PERMISSION FOR MY CHILD TO PARTICIPATE IN THE YOUTH ACTIVITY LOUNGE, DOSOMTHING), ITS/THEIR DIRECTORS, AGENTS, OFFICERS, VOLUNTEERS, CONTRACTORS, EMPLOYEES, ITS/THEIR HEIRS, SUCCESSORS, AND ASSIGNEES (EACH CONSIDERED ONE OF THE "RELEASEES" HEREIN) FROM AND AGAINST ANY AND ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES, KNOWN OR UNKNOWN, INCLUDING DIRECT, INDIRECT, PUNITIVE, INCIDENTAL, SPECIAL, AND CONSEQUENTIAL DAMAGES, CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY MY CHILD'S PARTICIPATION IN THE ACTIVITIES. WITHOUT IMPLICATION OF LIMITATION, THIS RELEASE APPLIES TO: ALL LIABILITY CAUSED BY THE NEGLIGENCE OR FAULT OF THE RELEASEES OR OF ANY SUPPLIERS OF THE SERVICES THAT COMPRISE THE ACTIVITIES; ALL LIABILITY RESULTING IN WRONGFUL DEATH, PERSONAL INJURY, OR PROPERTY DAMAGEOR LOSS; ALL LIABILITY CAUSED BY THE INABILITY TO USE OR FAILURE TO PROVIDE ANY OF THE SERVICES COMPRISING THE ACTIVITIES; ALL LIAIBLITY CAUSED BY DEFAMATION OR INVASION OF PRIVACY; AND ALL LIAIBILITY DUE TO ANY OTHER CAUSE WHATSOEVER.
